**Expression of Interest (EOI) for consultancy services of
“Project Management consultant”
For
Gujarat State Highway Project- II.**

1. The Government of India on behalf of Government of Gujarat (hereinafter called "Borrower") has applied for financing from the International Bank for Reconstruction and Development (IBRD) (hereinafter called "WB") in the form of a ("loan") (hereinafter called "loan") toward the cost of Gujarat State Highway Project - II. The Borrower intends to apply part of the proceeds for consulting services.

2 The consulting services (“Services”) include:

The Project Management Consultant will be broadly be responsible for to efficiently manage the project through assistance to PIU of the employer and to the employer such that envisaged each and every activity of the project is completed in agreed timeline, within estimated budget and in full compliance with the WB guidelines and applicable Employer’s acts, rules and regulations. The objective is also to ensure compliance to loan agreement covenants and to achieve project monitoring indicators in stipulated time frame.

Gujarat State Highway Project – II involves mainly three components namely civil works, institutional-Governance strengthening and road safety.

Civil works

This component aims at improving @ **1000 km** of state roads through different modes of execution.

PPP mode:

It involves four lane widening of 2 corridors of aggregate length of @ 195 km roads on BOT (toll) and BOT (annuity) basis each. DPR for annuity corridor is ready while feasibility study for toll corridor done earlier is being updated. Both civil work procurement would be on ICB basis and would involve services of IE.

Item rate:

The rest improvements i.e. in respect of @ **805 km** are on item rate basis and would involve services of at least supervision consultants.

The Government of Gujarat has prepared / got prepared DPRs and bid documents for @ **500 km** of roads (Phase I). The bids for construction for improvement of these roads are being shortly invited. The construction of target improvement involve improving existing State Highways including geometric improvements and realignments, Widening to 2L,2L+HS,2L+PS+HS,4L and strengthening and rehabilitation. The construction works are to be supervised by the supervision consultant and offer for which is being invited. This consultancy would be for about 40 months.

DPR preparation for @ **500 km** of roads is yet to be taken up. Consultancy service would be hired for the same. There are associated requirements in respect of civil works such as pre and post construction users perception / satisfaction surveys, human resource assistance to employer for environment, social and financial monitoring of project.

Institutional – Governance strengthening:

Four major and a couple of minor consultancies are envisaged under this component. TORs for major consultancies have been prepared and is in different stages of approvals. The first of the series of these four consultancies will be procured by November 2013. These consultancies would run for almost entire period in series with some overlaps.

Road safety:

Road safety management capacity review of the state was carried out by the World Bank. A batch of actions have been identified. These actions involve policy reforms and demonstrating how conjoined actions of road, transport, Police, Health and Education / Media /Awareness can bring out effective road safety. Conjoined actions will be deployed on a demonstration corridor which is identified in form of 2 sections aggregating length of 30 km of Dahej – Valia road. Base line surveys on these corridors are in progress and would be completed in couple of months. Policy reform, which inter alia also involves training and good purchase, will deploy a couple of consultancies. The scope of the current consultancy will be to help implementing the action plan on the demonstration corridor including assisting in procurement of related works, goods and services and overall monitoring.

IT-ICT-MIS Integration and GAPS Analysis

Employer has engaged the consultant for IT-ICT-MIS Integration and Gap's Analysis of present IT systems and resources being used by R&B Dept. The consultant has to submit report of findings of GAPS as well as how different existing IT system can be integrated and for that he will recommend the requirement of software and hard ware. PMC has to assist in procurement of the agreed hardware and software.

Quality assurance and technical assistance

For rehabilitation works, QA/TA would be involved till the end of DLP period. Construction period of such works would be @ 12 to 15 months and DLP period would be for @ 12 months. DPRs of these works are ready. Bid documents are also ready and bids are being invited separately.

Information is to be furnished by sole applicant or members of JV individually (Annexure II).
3. If present firm is the successor to or outgrowth of one or more predecessor firms, fresh name(s) of former entity (ties) and year(s) of their original establishment with details in aforesaid manner. Information is to be furnished by sole applicant or members of JV individually (Annexure II).
4. Present a brief narrative description of the firms. Information is to be furnished by sole applicant or members of JV individually (Annexure II).
5. List of not more than two (2) principals who may be contacted by this Office.
Listed principals must be empowered to speak for him or for the firm on policy and contractual matters. Information is to be furnished by sole applicant or members of JV individually.(Annexure II)
6. Under this item, indicate financial figures from consultancy business for past 5 (five) financial years. (Annexure III)
7. (i) Organizational strength of consultant and its constituents in case of a JV shall be given. (Annexure IV)

(ii) Office logistics for consultant and its constituents in case of JV in terms of office space, Engineering software. Availability of engineering software which are web enabled and have not less than 10 concurrent user license shall be mentioned (Annexure V).
- 8 Consultant's experience shall be given under three categories. The first category (A) shall be of supervision consultancy. The second category (B) would be of QA-TA, IE and the third category (C) would be Design / DPR preparation / proof checking of designs/DPR. Experience in above three category would be reported for similar nature road works and other widening and strengthening and / or rehabilitation road works. In case of JV applicant, each member has to likewise give above information. Only those works which are done as prime consultant need to be reported.

Section - IV

Short listing Criteria

- a. **1.** Consultant can be a Joint venture of not more than 3 firms. No Consultant can bid for a given work simultaneously as sole Consultant and as a member of any joint venture.
- b. **Annual Turn over**
 1. Annual turnover of any one of the last five financial years i.e. from **2008-2009 to 2012-2013** updated to the current financial year shall be more than Rs **65** crores. In case of JV, the lead member shall have more than Rs **50** crores of annual turnovers (updated) of any one of the last financial years. This threshold for each other member shall be Rs **25** crores.
 2. For arriving at updated value, turnover of any financial year shall be multiplied by the enhancement factor corresponding to that year.
- c. **experience**

Consultant must have as prime consultant successful experience as follows:

 - ± At least one Project having similar work costing not less than **1000 cr**. For JV, qualifying length for lead member would be **800 cr** and for other partner / s it would be **400 cr**
 2. Such work must have been completed within last ten Calendar years including **2013**
 3. A work would qualify as similar work if it meets with following:
 - a. Supervision consultancy (IE,PMC,TA-TA will not be counted)
 - b. Work execution on FIDIC conditions

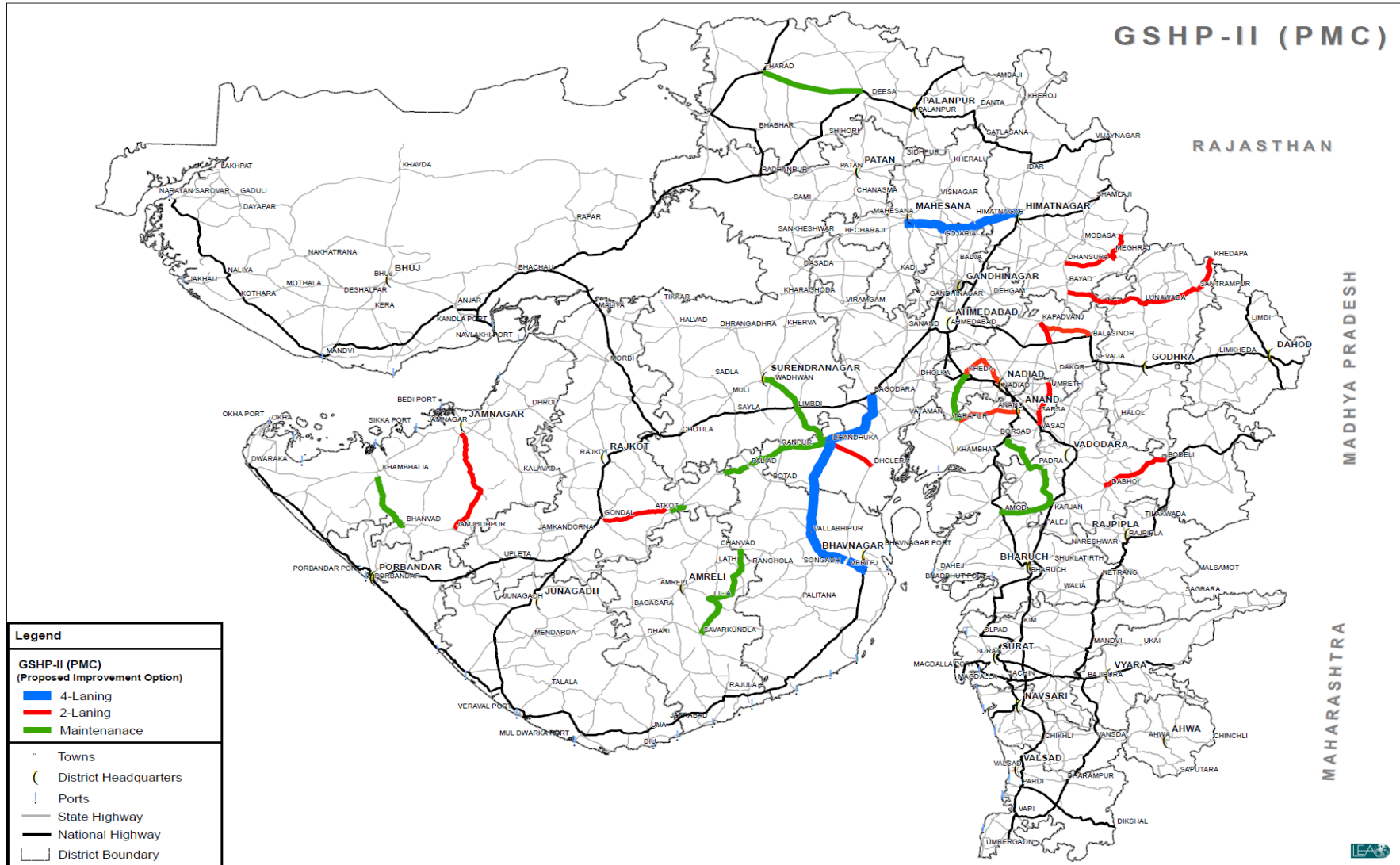
