Consultancy Services for System Integration of R&BD IT/ICT Applications

The Government of Gujarat (GoG) through the Government of India has received a loan from the International Bank for Reconstruction and Development (the Bank) towards the cost of Second Gujarat State Highway Project (GSHP-II). A part of this financial assistance is to be applied for procurement of this consultancy services.

Roads and Buildings Department is currently having several software applications (web based) for various needs of the department at different levels. Each of these applications is independent and caters to specific needs in standalone modes. This setup of different applications in the department, requiring different level of data, operations and manpower is proving to be inefficient for timely retrieval and use of information. Therefore, the Department has decided to integrate all applications and create a common integrated platform with existing applications and development of new modules needed to provide efficient, outcome-oriented and data-driven business processes of the Department. In this regard R&BD has initiated procurement of an IT consultant to study, analyze and develop integrated platform with existing applications and new modules.

The objectives of this Consultancy Services are:

- Improve the business processes/functions of department by developing an integrated platform through effective use of Information Communication and Technology (ICT)
- An Efficient System to monitor R&BD Schemes, Budgeted Works and Road maintenance activities.

The Project Implementation Unit (PIU) of the R&BD now invites eligible Consultants / Agencies to submit an Expression of Interest (EOI) for the provision of these services. The firms will be short-listed based on the following criteria:

- 1. Evidence of similar completed consulting services rendered.
- 2. Comparable services rendered to Government (or semi-Government) organizations.
- 3. The consultant firm's financial situation including fee income of the last five completed financial years.

- 4. Availability of relevant Key Professionals with the firm.
- 5. References from previous employers / clients for the similar services.

Consultants may associate with other firms in the form of a joint venture or a sub-consultancy to enhance their qualifications. The type of association should be clearly stated in the EOI submission.

A consultant will be selected in accordance with the World Bank guidelines: Selection and Employment of Consultants under IBRD Loans and IDA Credits and Grants by World Bank Borrowers of January 2011, based on the Quality and Cost Based Selection (QCBS) criterion. It is anticipated that requests for proposals will be issued in the month of January 2019.
