Opening Remarks:-

At the outset the Chief Engineer (WB) welcomed the representatives of various prospective bidders for the Civil work "Rehabilitation Rehabilitation of Karjan - Borsad Road SH-160 &SH-06 packaged as "GSHP-II/NCB/04" . A brief status of the project was presented.

Chief Engineer (WB) mentioned that as per the bidding document written queries were to reach PIU one week before the pre-bid meeting. However no such written query was received in the stipulated time. He mentioned that PIU has received some written query a day or two before the pre-bid meeting most of which, he mentioned pertain to qualification requirements. He invited the attendees to raise any further matter they wish to get clarification on any of the aspects of the bidding document and the project.

Mr.Samrathdan Zula from Anish Infracon India Pvt. Ltd raised issue of non availability of Indices for heavy machinery and parts used in Clause 47 of GCC .Attendees were invited to give their further queries in writing today itself. It was made clear to the attendees that they will get fourteen days to submit Bid after issuance of clarifications/Addenda in response to their queries. Chief Engineer (WB) informed the attendees that PIU will review these requirements and shall convey in writing requisite clarification to each of the query.

In the end, Chief Engineer (WB) urged the attendees to thoroughly go through bidding document and comprehend stipulated requirements more specifically related to environmental and safety in giving their bids. The meeting ended with a vote of thanks to the chair.
