- 1. The Consultant (Audit firm) shall be empanelled with C&AG in the panel of audit firms eligible for major audit.
- 2. The Consultant (Audit firm) shall be independent of the entity to be audited.
  - a. No partner of the audit firm or any qualified employee of the firm is related to any officer of the Project. Relative would mean husband, wife, brother or sister or any lineal ascendant or descendant.
  - b. Neither the firm nor its partners or Associates have any interest in the business of the project.
  - c. From the time of appointment and for the one year after (to be counted from the date of issue o internal audit report) the Firm ceases to be Internal Auditor, no other assignment of any kind to the project (including consultancy) will be accepted, either b the firm or by its partners or relatives of partner of the firm or by its associates.
  - d. The audit will not be done by a person who was either an employee in the project or a partner/employee of the retiring auditor, unless such person is employed with the firm for at least one year.
- 3. The Consultant (Audit firm) is not one against which disciplinary orders have been issued by the Public Companies Accounting Oversight Board and these orders are in force.
