We have reviewed the Bid Evaluation Report (BER) and have following comments:

1. The bids were opened on June 15, 2013, instead of June 11, 2013. The reasons for this change have not been documented in the BER. This should be done for clarity. There has been delay in carrying out the evaluation and submission of BER to the Bank. It is requested that in future the project should strive to carry out evaluation and submit BER to Bank within 45 days from the date of bid opening and if there are delays then the report should clearly state the reasons.
2. We note from the BER that the bids were valid only till September 12, 2013, though the BER was submitted on September 30, 2013. As informed the bid validity from all the bidders was requested and the same has been received and the bids are still valid.
3. There are typo errors noted in the BER which should be corrected. The price of Patel Infrastructure as per the read out is INR 582,111,489.00 and the discount given is 4.76%. The amount after the discount works out to INR 554,402,982.10. However the BER indicates the amount of discount as INR 554,286,560.57. **However, we note that this does not change the overall ranking of the firm .**

We have reviewed the Bid Evaluation Report (BER) and based on the information provided, Bank has no objection to your recommendation to award the contract to the lowest evaluated substantially responsive bidder who is qualified to perform the contract as per disclosed post qualification criteria as per details given below:
